Following a discussion around green waste bins at our last general meeting, we can clarify that the Household Waste Recycling Centre (aka 'the tip') at Stourbridge and the pop up sites at Lister Road, Dudley and Northway, Sedgley do indeed accept garden waste.

The next dates for the pop-up tips are:

- 6 July 2024 Lister Road, Dudley
- 20 July 2024 Northway, Sedgley

# Items too good for the tip? Try community reuse and recycling events!

On Tuesday 9 July between 10am and 3pm, Dudley Council is holding a third 'Too Good To Throw Away' event - this time at The Halesowen Housing Hub on Andrew Road.

People will be able to donate (small) unwanted household items (no furniture or white goods) that are in good working order including curtains, bedding, cushions, kitchenware, small electrical items, clothes, food and unused toiletries. The items will be shared between charitable organisations in the borough, including Provision House, which repurposes them for community use.
