<u>No</u> Cars are to be left on the Park whilst the Fun Day is in progress. This includes behind stalls. Cars must be off site 15 minutes before the start of the event (9:45 am). At this time Park Barriers will be reinstalled and not removed until 5:15pm. You will be directed to offsite parking areas.

Any vehicles larger than cars must have prior permission to bring them onto the site.

No food or drink is to be sold on stalls. This is due to the catering stalls already been allocated.

All rubbish must be taken with you after the event and your pitch left as you found it.

<u>No</u> pitch locations are guaranteed. You can not choose where you are located on the day. You will be told where you are to be sited by a steward.

All stalls will be allocated a pitch roughly 12 foot x 12 foot square. Only one standard gazebo per pitch is allowed, unless you book more than one pitch.

No equipment will be provided (i.e. tables, chairs or gazeboes).

All money paid is non-refundable if you fail to arrive at the event. The Fun Day is a funded event, money paid may have been used to sponsor other activities on the day.
